Standard turnaround time from receipt of payment is about 3–5 weeks. The Museum will fulfill requests in the order they are submitted. If staff time permits, turnaround time for materials can be expedited to 1-2 weeks; this will incur a 25% surcharge.

Terms & Conditions

1. **Permission for reproduction is limited to the applicant and is non-transferable and may not be reused on another project, assigned, or sold without the permission of the Museum. Permission for reproduction is granted only for the express purpose described in this form.**
2. All requests for use of the Images will be considered by the Museum on a case-by-case basis.
3. Defamatory, pornographic, or otherwise unlawful use of the Images is strictly prohibited. The Images shall not be incorporated into a logo, trademark, or service mark.
4. Except to the extent explicitly provided in this form, you may not make the Images available in any medium in a manner intended to allow or invite persons to download or extract the Images.
5. You shall have no right to recast, adapt or transform the Images (except to the extent explicitly provided in the form) without express written permission of the Museum.
6. The Museum shall retain all ownership, including all copyright rights, in the Images. Upon request, you agree to provide the Museum with a copy of any publication in which the Images appear.
7. The Images must always be accompanied by a credit as follows: **Collection of the National Law Enforcement Museum, [Accession number in this format: 20XX.XX.XX]**. Photo credit must appear either in immediate proximity to the Image or in a section devoted to acknowledgments.
8. All charges are due in advance, unless an alternative payment schedule is agreed to by the Museum prior to the time of the order. The fees cover only the specific use of the Images detailed on this form. Any subsequent or additional use, in any form or media, requires that you obtain a new right to use the Images.
9. **Each of the Images is provided "as is," without warranty of any kind, either express or implied, including without limitation any implied warranties of merchantability or fitness for a particular purpose.** You shall be solely responsible for determining whether a release is required in connection with any proposed use of the Images, and you shall be responsible for obtaining any required release.
10. You agree to defend, indemnify, and hold the Museum and its affiliates and their respective officers, directors, employees and agents harmless from all damages arising out of or as a result of claims by third parties relating to your use of any Images outside the scope of this Agreement or any other breach by you of this Agreement.
11. If you breach any of these Terms & Conditions, the Museum may terminate your permission to use the Images upon 5 days written notice to the address set forth above. Upon termination, all rights granted to you in the Images shall terminate and you shall promptly deliver to the Museum, or destroy at the Museum's request, all Images and copies thereof in your possession.
12. IN NO EVENT SHALL EITHER PARTY BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT, OR CONSEQUENTIAL DAMAGES OF ANY KIND IN CONNECTION WITH THIS AGREEMENT, WHETHER ARISING OUT OF BREACH OF CONTRACT OR TORT, INCLUDING NEGLIGENCE, AND EVEN IF SUCH PARTY HAS BEEN INFORMED IN ADVANCE OF THE POSSIBILITY OF SUCH DAMAGES.
13. The terms and conditions in this form represent the entire agreement of the parties concerning the use of the Images and may only be modified by written agreement of the parties.
